**MINUTES OF THE EUDORA CITY COUNCIL
REGULAR MEETING
FEBRUARY 4, 2013**

The meeting was called to order by Alderman Charlene Taylor, who chaired the meeting in the mayor's absence.

There were seven aldermen present at roll call. Alderman Turner arrived shortly after.

Alderman Allen asked if there had been an increase in the water rates. She was told the rates increase by 5% each year by ordinance. The minutes were approved with the necessary corrections.

Each alderman was given a financial statement on all city account funds for the month ending January 31, 2013. Mr. Clark Terrell, CPA for the city, asked for questions. He told the council that the IRS received the offer of compromise and is conducting an investigation. This is standard procedure. The city will be contacted by June 3, 2013. We have to continue to make the payment we volunteered to pay. The monthly IRS payment is \$1,175.00.

Mrs. Turner gave the mayor's report in his absence. She reported that Reynolds Radio will have the concrete poured for the tower by February 8, 2013. The mayor informed the council last meeting of the new bonding for the city. He will go over the packet with the council at the next meeting. There are three committees who determines who get the projects and who doesn't. It is a twenty-one million dollar project.

Attorney Mazzanti reported that a class action lawsuit was served on the municipal clerk. There is a statue that mandates when someone receives a speeding ticket and that person is wearing a seat belt, that person is entitled to a \$10.00 reduction in the fine. The law suit alleges that the clerks are not deducting the \$10.00.

Alderman Serio asked how far they can go back. Attorney Mazzanti said five years.


Faulkner Pipe of Greenville, MS did a presentation to the council and citizens on an Automated Water Meter System. Mr. Shepard has been in business for 53 years and Mr. Moss is the owner of the company. Their presentation showed how the automated meter reading system would generate revenue for the city. Alderman Taylor suggested that this item be tabled until the mayor is present.

Alderman Allen made the motion to adopt a resolution establishing the Eudora City Council Agenda Speakers and Citizens Communication Policy. Alderman Farris seconded the motion. Motion carried. The motion is adopted.


